If you attempt to go to musingsfromthemoon.com it will attempt to plant a virus onto your machine. The virus is Trojan-Clicker.JS.Small.c and it will affect anybody that is running Microsoft Windows. After looking into the effects of this virus it redirects you from musingsfromthemoon.com and takes you to random web sites that seem to be connected similar to clicks that an individual would profit from. This is your typical scam where the virus will force random pop ups and when the sites are access the end result is the person on the other end making money at the expense of the victim. I have reason to believe that all of the above mentioned parties are involved with this. I currently have in my possession a screenshot connecting Torin Rozzelle to known Left Wing Cyber Terrorist Jeremy Hammond who is famous for hacking into the website protestwarrior.com and stealing almost 5,000 credit card numbers in an attempt to fund radical Left Wing organizations. I also have several e-mails from individuals that are close friends with The Rozzelle's detailing their behavior. I have full blog entries on my blog in regards to their activities.
